(3) <i>Community Partner Presentations</i>	Jennifer Mahan from Mental Health Association gave a legislative update: Official concurrence in Senate and House versions of Mental Health Parity Bill passed. Substance Abuse is not covered in the Bill. The Bill covers all group plans, mandates coverage, 9 diagnoses at full parity, PTSD, anorexia nervosa/bulimia, schizophrenia, obsessive/compulsive disorder, bipolar disorder, major depressive disorder, schizoaffective disorder, major depressive disorder, anxiety disorder. Other disorders are covered at financial parity. State Collaborative had a role with state agencies working together. Law effective July 2008. There is support from some legislators to work on the substance abuse coverage. There is a Bill around Coordination of Children's Services which requires the formation of a Council. Governor's proposal to cover health benefits for children beyond age 18 has House Support. Senate proposes applying for Federal Medicaid Waiver, with start July 2008. Discussion regarding DJJDP zero based budgeting. Timeframes would not allow contracts beyond 6 months in the final year of the budget, making it difficult to lease space, etc. Proposal for Office of Evaluation to oversee how evaluations are conducted in state programs. Legislation mandating participation in CFTs by all state funded nurse positions. Reference in the 2007-2008 Appropriations Bill is SECTION 10.23.(b) All school nurses funded with State funds shall participate, as needed, in child and family teams.
