Discussion Topics/ Presentations</b></p>	<p><b>Periodic Review of Principles</b></p> <p><b>Priority 1: Supporting local collaboratives</b></p> <p><b>Sharing information over our listserv-</b> We agreed on using key words in the email subject and not # anymore: example Communication for #1, CFT for #2, Data for #3</p> <p><b>Including representatives from local collaborative in our meetings</b></p> <p>Erin McLaughlin is checking on SC fund balance to see if we could pay for mileage when people come from local collaborative to present.</p> <p>Mark O'Donnell will speak with SOC Coordinators who are on the local collaboratives about presenting at our meetings.</p> <p>Will also ask to get a list of local collaborative chairs from SOC Coordinators. Erin will compile email list of local collaborative chairs, so we can keep in better communication.</p> <p>Libby will contact the local collaborative chairs about presenting at SC as well as having members of SC come and meet the LCs at their meetings (if there is interest).</p> <p>SC will establish agenda in advance and publicize it so SOC Coordinators and other members of local collaborative have enough time to determine if SC agenda is applicable to them and make arrangements to attend.</p> <p>We are also working on having a link to the agenda on the website.</p> <p><b>Including more parents and youth in our meetings</b></p> <p>Rick Zechman will see about using money from TA workgroup for parent participation.</p> <p>By 2/1: Rebecca will draft a budget and narrative outlining costs and rationale for parent/youth participation for any member agency to include in future grant proposals.</p> <p><b>Priority 2 – Supporting Child and Family Teams</b></p> <p>The Training Team is using Mecklenburg's Child and Family Team Training Materials as foundation for online training. Should be released in June. Through links with DSS, funding has been established for Sayso members to attend meetings.</p> <p>Mark O'Donnell is leading meeting to include CFT/SOC trainings in NC State Curriculum...agency meeting is 3<sup>rd</sup> week in Dec.</p> <p>Larger Goal is including SOC and CFT trainings into numerous higher ed. programs such as Social Work, Public Health etc...</p> <p>Outreach to Faith-based: Rebecca will initiate, writing to Rev. Jean Rodenbough at NC Council of Churches by 4/1. Unless Rev. Rodenbough advises otherwise, Rebecca will then contact Raleigh area ministers as well by 6/1 to invite them to attend SC meetings.</p> <p>MOAs- not done regularly but yearly to every few years.
